40th ANNIVERSAY AMNESTY!



The CRTWH will offer a "Canadian 40th" Anniversary Amnesty Program to run from **April 1 to Dec 31, 2022.**

LATE REGISTRATIONS:

The Amnesty will apply to all unregistered animals over 1 year of age that are eligible for CRTWH registration but are not yet registered with CRTWH. All horses must parent verify through DNA before registration is granted. No matter the age of the horse, the cost of these registrations under the Amnesty, will be \$50 for members & \$80 for non-members. The Amnesty for Late Registrations will run from April 1, 2022 to December 31, 2022

TRANSFERS:

The Amnesty for "Transfer of Ownership" will apply to all animals that are registered in the Canadian Registry of the Tennessee Walking Horse but have not been transferred to the current owner. The cost for lapsed transfers will be a flat rate of \$25 for members and \$35 for non-members.

The Amnesty for Transfers will run from April 1, 2022 to December 31, 2022

REGISTRATION

Of any foal **bom in 2021 or 2022** and **registered in 2022** will be registered at **\$24.00**, a 40% discount. (\$40 less 40% is \$24) plus the normal cost of DNA parentage verification.

&

TRANSFER

Of any foal/horse owned by a CRTWH member and transferred in 2022 within one month of date of sale will be transferred at \$12, a 40% discount.. (\$20.00 less 40% is \$12)

These offers end December 31, 2022.

2022 MEMBERSHIPS ARE DUE




