# CRTWH MEMBERSHIP RENEWALS

# **STALLION TO GELDING:**

A Money-saving Reminder:

If you are selling a gelding that is still recorded on his papers as a stallion, please inform CLRC at the time you transfer the horse to its new owner. The registration papers sent to the new owner will be corrected at no charge to show he is now a gelding.

This must be done at the time of transfer to incur no extra charge.

Why is this important? It helps keep our pedigree records accurate, just as sending in notice of an animal's death helps keep our records up to date. You can send your deceased horse's registration papers to CLRC with a note saying when it died. Ask that the cancelled papers be returned to you and request the five dollar credit to your account.

### **DIRECTOR NOMINATIONS**
