ALBERTA WALKING HORSE ASSOCIATION CLINIC, March 24 & 25

The clinic, featuring Dr. Dave Whittaker of Middle Tennessee State University, was well attended by both riders and spectators. Dr. Whittaker did an excellent job of individualizing instruction for each horse & rider, while keeping it interesting and informative for the spectators.What Dr. Whittaker had to say on topics ranging from training to conformation to gaits, was not only entertaining but thought provoking. HORSE SHOW JUDGES'CLINIC, OKOTOKS - March 25 pm

On Sunday afternoon, the A.W.H.A. put on a Tennessee Walking Horse demonstration for the judges who were attending a week-end clinic designed to improve their knowledge of some of the 'lesser known' horse and pony breeds.

Dr. Whittaker gave a brief history and background of the Tennessee Walking Horse breed, and then called on each horse and rider to demonstrate various aspects, pointing out to the judges some the features of gait and movement to watch for. Then all the horses and riders worked together, and questions were invited.

I think the high point for the judges was after the formal demonstration however, when they were invited to ride a Walker for themselves and feel the difference. A bit hesitant at first, the judges were soon riding around the arena at a running walk, and the big smiles on their faces were proof that the demonstration had been a big success.

Our thanks to those who organized it, provided horses for it, rode in it, and to Dr. Whittaker for his excellent, down-to-earth presentation.

FIRST CANADIAN TWH, & OTHER QUESTIONS

Last newsletter I asked you if anyons had the answers to Cristine Holt's questions about who imported the first Walkers to Canada, and who is currently the largest breeder of Walkers.

Jack Gurnett looked up the reference to the first Canadian registered TWH in Grant McEwan's book, <u>Hoofprints & Hitching Posts</u> and sent me a photocopy: WThe bonce qualifying for registration Number 1 in the Canadian

The horse qualifying for registration Number 1 in the Canadian Tennessee Walking Horse Stud Book was, quite properly, Chief Justice Allen, bred in Tennessee and imported by C.H. Gilchrist of Manyberries

Allen, bred in Tennessee and imported by C.H. Gilchrist of Manyberries in 1941. This one was a chestnut, fifteen and one-half hands high and about one thousand two hundrel pounds in weight."

However, shortly afterwards, official recognition of the Tennessee Walking Horse breed was withdrawn, and the book remained closed for some years. Eventually it was reopened, and Chief Justice Allen was confirmed as entry #1, while entry #2 went to a mare named Granny Evans, imported and owned by George Edworthy of the Shagganappi Ranch, Calgary.

I had an interesting conversation with Jack Chapman of Stettler which probably answered Cristine's second question as to who is the largest breeder of TWH in Canada. Jack and Madelaine own 31 U.S. registered Walking Horses and 6 Canadian registered ones, as well as 11 part-bloods. They are expecting 18 to 20 foals this spring, due to begin arriving on April 5.

There are several others who have been building up breeding herds of Walkers. Some who come to mind are the McDonalds at Pouce Coupe, B.C., the Herbacks at Whitelaw, Alta., Gurnetts at Rimbey, Alta. and the Coles at Cabri, Sask. There are doubtless many more that I don't know about.

It really would be interesting to do a survey of the Walkers in Canada and perhaps publish a directory. Would anyone be interested in such a project? I'd be willing to publish it through the Walking Horse News if I could get provincial representatives to collect, compile and type the information. Write me if you'd be interested.

WHAT DO YOU THINK? - A Reply to the Jan./Feb. Column by J.M. Kingsland

"Although I am a newcomer to Walking Horses, I have many years experience in animal breeding, and during the last twelve years have proved some of my theories in swine breeding. However, swine genetics have a very fast turnover and all the 'mistakes' are easily disposed of. Horse breeding is longer term and should be carefully planned towards improvement of those future generations."

"Alberta has already formed a relatively small - but scattered - group of TWH breeders, absolutely bubbling over with enthusiasm for their horses. These people have brought in a wide selection of superior bloodlines that exist in the breed today. The breed is still young; some pedigrees still have unknown horses on them. The Alberta group have stated that they are intent on producing the NATURAL Walker."

"This, then, is the basic situation today and the question now is where are we headed? The comment in last month's newsletter was on the exorbitant number of stallions at stud and how this can very quickly bring about changes within a breed - not necessarily maintaining improvement."

"In Great Britain during the period 1940 - 1960 (approx.) it was <u>ILLEGAL</u> for anyone to use a boar or a stallion without a license. A license was issued only after the animal was registered <u>and</u> inspected for breed type and conformation. To this day, only licensed stallions are allowed to run the moors to maintain the bands of wild ponies (New Forest, Dartmoor, Exmoor). British Breeds are now enjoying top demand on world markets because they have such a sound and solid background."

"I feel we have the perfect situation here in Alberta to start a simple classification system on potential breeding stock which would help all Walking Horse breeders to work towards the same goal - the <u>Natural</u> Walker, and to keep within certain guidelines on conformation, type and colour."

"Both mares and stallions should be classified, preferably in the spring of their third year, under saddle to show natural gait. Dr. Whittaker, at the March 24 clinic stated that breeders in Tennessee are now tending towards the <u>Natural</u> Walker. Endorsement of such a scheme by the TWHBEA would help to get it started and train Alberta people to carry it forward."

"Classification would not destroy the breeders' individuality, but would ensure that however many miles apart the herds are, a Tennessee Walker will always be a Tennessee Walker. Serious breeders will maintain a nucleus of Top Rated breeding stock and this will naturally provide for a sliding scale of prices. We could be losing some top class animals (especially mares) by not identifying and publicising them."

"Entering a Show-Ring is not everyone's 'cup of tea' - classification eliminates the owner's skill or lack of skill. A fairly large number of stallions will not be so harmful to the breed if they really are all good ones. However, an <u>un</u>classified stud will create some doubt in the minds of owners of top-rated mares and would not be used so willingly by serious breeders."

"In a very few years we could be selling those <u>NATURAL</u> Walkers back to Tennessee: This has already happened in other breeds of livestock, and Alberta is already recognised on the WORLD MARKET."

Well, Readers, what do YOU think? Write and let us know your opinions. Personally, I would like to see a system such as Jo suggests above. I think the A.W.H.A. Futurity and the Alberta Horse Improvement Program are trends in the right direction already, but, as Jo points out, the element of showmanship enters into these. The success or failure of a classification system would, in my opinion, rest on whether we could find judges whose knowledge & horsemanship we could all respect and whose decisions would be accepted. But just think of the possibilities for breed improvement if we could get togethe. 1

QUESTION: Do you longe a young horse? If so, do you aim to get a Running Walk; should they do this naturally at this stage without a rider; do you stop them if they break into a trot? Do you allow them to canter on a longe?

ANSWER: By "young" I am going to take the liberty of thinking you mean two to three years of age.

Yes, I do longe my young horses. As a matter of fact I longe all my horses no matter what age.

This form of schooling is an excellent way of allowing a horse to relax. And, as we have learned there is no way our horses will perform well if not relaxed. Also, we can take this opportunity to see what our horses' tendencies are in their movement.

I'm a firm believer in voice communication with a horse. Especially with pleasure horses or horses that more than one or two people are going to ride, which both would be the case with yours.

The longe line is a great means of this communication becoming understood. You must be very consistant with your commands, praises, and reprimands. Tone of voice is extremely important. Praise must be praise. Criticism must be just that.

Don't expect the running walk out of the horse unless she is very natural or very schooled. This will come eventually, but, eventually may be years. And that's okay, it's not important. This is not the benefit or importance of the longe line work.

The benefit is allowing a loose, relaxed flat walk. The horse isn't having to worry about the weight or movement on her back of a rider. This is why you must be consistant and quiet at the end of the line. Don't be bothering the horse with your "nonsense." Certainly, the horse must be very aware of you as leader but not as agitator.

If you note that your horse takes even a hair longer stride, praise her. Then lay off the praise until she does something better again. She'll soon pick up on what she is doing that pleases you. Remember, most Walkers really enjoy pleasing.

Definitely disallow trotting on the longe line, especially if this is what the horse prefers to do in place of the running walk. If your horse breaks or begins to break into the trot, use your decided-on reprimand and bring her immediately back to a walk. But, the key here is not to allow her to die into a "dog walk." Insist on a walk with impulsion. You may find this is when she achieves the best stride. Praise her and keep working toward extension.

You bet, canter on the longe. Age and body structure has to be a determinant here. I won't canter a two year old very long on the line because of the pressure and trauma allowed the inside legs. But, it's a great way to teach the transition into the canter with many strides to follow. Once again, the horse isn't having to contend with lifting her and your weight into this gait. Relaxation is a great benefit of the longe line for the canter as it is for the walk.

You're much better off if you have an enclosed round or square pen. Ideal size would be 50-60 feet in diameter. If you're not fortunate enough to have this arrangement, any kind of enclosure is better than none. Such as a regular riding ring where you have three sides enclose when longeing or even one or two walls is better than none.

The more enclosed your work area is the more balanced the horse will remain. This is because the horse is not frying to pull away from you toward the open space and likewise you are not having to pull the horse toward you at the open parts of the circle. If either of these occur, this section of the circle is more detrimental than educational.

If you have an enclosed structure, you may find that once your horse understands your commands it is better yet to longe without the line. Or, maybe alternate free and line longeing. Once again, the benefit of free longeing is that there is no one-sided pull being put on the horse so she is better able to be balanced, and that is one of our main goals; balance.

Please, any of you who decide to longe your horse, remember, these lessons don't begin on the end of a 20-30 foot line but on the halter rope with the horse at your side until they understand your voice communication tools.

FROM DARLENE HARDER, BOISSEVAIN, Man. and BONNIE BROWN, ENDEAVOUR, Sask. "After carefully reading the Rule Book for the new Canadian Walking Horse Registry, we have some misgivings. Our main complaints are with the fees. We do not believe that the following is just and fair:

'No application for registration of Canadian born animals will be accepted later than 12 months after the foaling date except at an additional surcharge of \$100. This surcharge is in addition to the regular fee and is non-refundable, whether the application is approved or not.' "

"Some of the reasons we do not feel it is fair are as follows."

"What if a new owner or breeder that is in the business of raising TWH is not aware of this rule? Perhaps they would not know about it if they were not a few of the 'selected few' that were in charge of setting up these new rules. After all, this new registry is going to be something rather unheard of for awhile as it has not been widely publicized."

"Also, why are they so scared of refunding the surcharge if they do not approve the animal? I would like to question the reasons for these stiff penalties, and why they are being imposed. Is the main reason behind this new registry to insure that it is a money-making deal, or is it to establish a reputable and respected registry for our breed?"

"Except for a few areas, Tennessee Walking Horses are <u>not</u> well established in this country. I don't think that fees like the ones imposed by this new registry will encourage new members and more horses."

"I have owned Walkers for 14 years. It has been a great struggle for me to increase the number of owners and the numbers of their horses because of finances. I am really afraid it will be even worse now. I feel that this \$100 that is non-refundable will discourage people from registering their horses with the Canadian Walking Horse Registry."

"I will be greatly interested to see the replies of other readers to my comments." Darlene Harder, Boissevain

FROM HELEN WILLIAMSON, CANADIAN WALKING HORSE ASSOC.

"The fee for registering an animal within six months of foaling date is 015 for members and \$25 for non-members of the C.W.H.A. After six months but less than twelve months, the registration fee is \$20 for members, \$30 for non-members. The fee for registering animals after the twelve month period is \$100. This is because of the research required in tracing back to the breeder and finding size and dam requires a great deal of work. This \$100 fee is the same as is charged by the two Tennessee Registries."

"The fee for transferring an animal that is already registered with one of the American registries, if applied for within three months of sale, is \$10 for members and \$15 for non-nembers, This fee escalates according to the time elapsed after date of sale,"

"These fees are not out of order in price and most people who are breeders register their animals within the six month time frame. The Registry is with Canadian National Live Stock Records in Ottawa and they charge for every piece of paper that crosses their desk. Now you can imagine the paper work and letters involved with searching out parentage for an animal that is four years old and has been sold twice. So this fee is not unreasonable. The point being, if you have a purebred animal, it should be registered within six months of foaling and the cost is nominal."

"I agree that the Registry should be advertised more, but unfortunately it costs a great deal to advertise, and the Registry is not yet a well established one with a great deal of funds. Until the Registry has received the annual statement from Ottawa with their charges, we cannot afford to spend on extensive advertising. The more people who support the Registry, the more we'll be able to spend on advertising. So spread the word, please, all of you

ELAINE JOHNSTON, DRUMHELLER, writes, "It occurred to me, as I read the Jan./Feb. issue of the <u>Walking Horse News</u>, that the main problem seems to be the lack of public awareness."

"I was raised in the city and my first encounter with the TWH breed was at the age of ten. My cousin bought a beautiful black stallion which I saw only once, as she sold him to someone better able to train him. "Then last week we were visiting some friends of ours who own reg'd Quarter Horses. Iasked my husband what was wrong with these animals. They were so stiff legged that I thought they must have something wrong with their hindquarters."

"I know many people will scoff at my ignorance of the different horse breeds, but I'm sure I'm not the only one."

"My husband, Richard, is planning to use Russet and Lil for ranch work and we are very pleased with their good nature and keen awareness of their environment. We enjoy the <u>Walking Horse News</u>. Keep up the good work."

PRICES SURVEY

A few more replies have come in regarding prices, along with this comment.

"Regarding the issue of putting a price in the ads. A lot of people shop by price alone. The lowest price is not always the best buy concerning horses. Some horses, whose price may be higher, have had a lot of time and money spent on their upkeep. (Training, trimming, shoeing, worming, shots, etc.) This, of course, is not explained in the ad, and therefore, the person who shops by price alone would not consider this animal, which might, in reality, turn out to be the best buy."

"Breeders travel many miles acquiring good breeding stock and this is certainly not done for nothing here in Canada. This must all be considered in the price of an animal."

"I feel that it should be at the discretion of the advertiser as to whether the price appears in the ad. This is only my opinion, of course."

I'd still like to get more prices before tabulating the survey. It would be great if we could get 100 or more replies since the bigger the sample, the more it will give us a true indication of prices. If you haven't sent yours in yet, please do. It promises to be very interesting.

I knew there was something special about this horse, but I hadn't really thought of Walkers again until my husband started talking about buying a Tenn. Walking Horse."

"We now have two. In July we bought a sorrel yearling filly, HC Lil May Walker, from Arne Hauge and in November Betty Neuman sold us her 4 yr old chestnut mare, Russet Star. Both of these TWH were sired by He'za Walker."

"In the few months that we've had them, I've gotten used to their long easy gait. It's fun watching them with our little Shetlands, and it's so easy to see the difference in their walk, although you can't compare the horses with the ponies in any way."

"Then last week we were visiting some friends of ours who own reg'd Quarter Horses. Iasked my husband what was wrong with these animals. They were so stiff legged that I thought they must have something wrong with their hindquarters."

"I know many people will scoff at my ignorance of the different horse breeds, but I'm sure I'm not the only one."

"My husband, Richard, is planning to use Russet and Lil for ranch work and we are very pleased with their good nature and keen awareness of their environment. We enjoy the <u>Walking Horse News</u>. Keep up the good work."

PRICES SURVEY

A few more replies have come in regarding prices, along with this comment.

"Regarding the issue of putting a price in the ads. A lot of people shop by price alone. The lowest price is not always the best buy concerning horses. Some horses, whose price may be higher, have had a lot of time and money spent on their upkeep. (Training, trimming, shoeing, worming, shots, etc.) This, of course, is not explained in the ad, and therefore, the person who shops by price alone would not consider this animal, which might, in reality, turn out to be the best buy." "Breeders travel many miles acquiring good breeding stock and this is

"Breeders travel many miles acquiring good breeding stock and this is certainly not done for nothing here in Canada. This must all be considered in the price of an animal."

"I feel that it should be at the discretion of the advertiser as to whether the price appears in the ad. This is only my opinion, of course."

I'd still like to get more prices before tabulating the survey. It would be great if we could get 100 or more replies since the bigger the sample, the more it will give us a true indication of prices. If you haven't sent yours in yet, please do. It promises to be very interesting.

ALBERTA WALKING HORSE ASSOCIATION FUTURITY

GENERAL PROVISIONS

The Alberta Walking Horse Association will this year offer three divisions. A foal whose parents were nominated the year of the foaling is eligible through the 2 year old year providing all Futurity conditions are met. It is not necessary that a foal be shown in any given year in order to maintain eligibility so long as yearly entry fees are paid and all other conditions are met including having been foaled in Canada.

WHAT FOALS ARE ELIGIBLE

A foal, to be eligible, must be registered or in the process of being registered with the Canadian Walking Horse Association Registry. It's sire and dam must be nominated by the closing dates of the year foaled. The foal must be entered and all fees paid by the closing dates in its weanling year and each year following to remain eligible.

NOMINATION OF SIRE To nominate a stallion in the Futurity it is necessary that:

- 1) the stallion be registered with the Tennessee Walking Horse Breeder's and Exhibitors Association and/or with the Walking Horse Owner's Association and/or the Canadian Walking Horse Association Registry, and
- 2) a fee of \$35.00 (member) \$40.00 (non-member) be paid to the Futurity on or before the closing date of April 30th in the year the foal is born. Late nominations made after April 30th will be assessed a 50% additional premium.

NOMINATION OF DAM

The same conditions as sire. Fees to be paid are \$10.00 (member) \$15.00 (non-member).

THE WEANLING DIVISION

In order for a foal to be eligible to show in the weanling division of the Futurity, the following conditions must be met:

- 1) the sire and dam must be registered the the TWHBEA and/or with WHOA and/or CWHA.
- 2) the sire and dam must be nominated in the Futurity in the foal's weanling year.
- 3) the foal must be registered or registration applied for with the CWHA.
- 4) all foals, whether born or not, must be entered by the futurity closing date of July 31st in the foals weanling year and a \$10.00 fee (members) \$15.00 fee (non-members) paid to the Futurity. The entry fees for foals born after the closing date may be rebated upon presentation of a veterinatian's certificate of a still-birth or birth deformity.

THE YEARLING DIVISION

In order for a colt, filly or gelding to be eligible to show in the Yearling Division of the Futurity, the following conditions must be met:

- 1) the colt, filly or gelding must have been entered in the Weanling Division of this Futurity and all conditions and requirements of that division fulfilled including registration.
- 2) a total fee of \$40.00 (member) \$60.00 (non-member) be paid in two installments, one half by April 30th and the remaining one half by July 31st the year the entrant becomes a yearling.
- 3) entrants in this division will be shown in hand with a bridle or show halter. Colts, geldings and fillies will be shown separately.

THE TWO YEAR OLD DIVISION

The same conditions is the yearling division with the following additions:

- 1) the colt, filly or gelding must have been entered in the Yearling Division of this Futurity, whether shown or not, and all conditions and requirements of that division fulfilled.
- 2) a total fee of \$40.00 (member) \$60.00 (non-mem) be paid in two installments, one half by April 30th and the remaining one half by Jly 31st the year the entrant becomes a 2 year old.

FEES

All payments to the Futurity must be paid to the Alberta Walking Horse Association Futurity by the stated closing dates.

LIABILITY

No entry is liable for more than the amount paid in, but there will be no return of a payment except as provided in item 4 of the Weanling provisions. The Alberta Walking Horse Association reserves the right to reject and to debar any entry from competition for failure to comply with any conditions of the Futurity. Each exhibitor, owner or breeder entering the Futurity releases the Futurity committee and the AWMA of any liability resulting from loss or damage during the Futurity.
